Tickets will be available online at www.splitthepot.ca, via phone by calling 1-833-804-6262 and select convenience stores (see below list of locations).

All purchasers must be at least 18 years of age and be within the province of Ontario at the time of purchase.

Regulations prohibit the following persons and their immediate families residing in the same household from purchasing a ticket and being eligible to win: Raffle Administrators and anyone involved in the administration or operation of the raffle, Foundation staff and board of directors of Waterloo Regional Health Network Foundation, and staff (including all employees and contractors) of licensed gaming suppliers providing services to Split the Pot Lottery. Any raffle tickets purchased by these individuals shall not be eligible to win.

It is possible for the same ticket number to win the Early Bird prizes and the Grand Prizes.

The total tickets available in the draw will be unlimited.

All inquiries, if any, regarding the “Chances of Winning” are to be made to the licensee prior to the purchase of tickets. Chances of winning depend on number of tickets sold as of the Deadline Date for that prize. Tickets will be issued using an electronic raffle system supplied by Ascend Fundraising Solutions.
